AGREEMENT BETWEEN YOU AND SPORTS TRAVEL HAWAII LLC

In the text that follows, the individual terms "Sports Travel Hawaii", or "Love Travel Hawaii", and collectively "STH & LTH", "we", or "us", refer to Sports Travel Hawaii LLC. The term "you" refers to any person visiting <https://sportstravelhawaii.com/> and/or <https://www.lovetravelhawaii.com/> ("Websites").

The Websites are provided solely to assist you in gathering travel information, determining the availability of travel and related goods or services, making legitimate reservations, and for no other purposes.

We offer the Websites, including all information, tools and services available from the Websites to you conditioned upon your acceptance without modification of these terms of use as well as our booking Terms and Conditions, and other policies and/or notices stated in this document, including without limitation our Privacy Policy, also available on our Websites (collectively, "Terms of Use"). Please read these Terms of Use carefully, as they contain important information about limitations of liability and dispute resolution.
